

American Gas Lamp Works LLC Limited Warranty

American Gas Lamp Works LLC (“AGLW”), 1299 4th Ave New Kensington, Pa warrants that its gas and electric lighting fixtures (the “Product”) will be free from defects in material and workmanship from the date of manufacture by AGLW for the following periods:

The GasGlow™ LED system consists of an LED light generation engine and aluminum stem and head assembly. GasGlow™ is typically also installed with a separately manufactured power supply suitable for LED lighting. These drivers carry separate warranties and are not covered by the AGLW GasGlow™ warranty.

This limited warranty is conditioned upon proper storage, installation, use and maintenance. This warranty is not applicable to any system which is not installed and operated in accordance with the current edition of The National Electric Code (NEC), the Standards for Safety of Underwriters' Laboratory, Inc. (UL), the Standards for the American National Standards Institute (ANSI), and with AGLW instructions and guidelines for the Product. This warranty is not applicable to any Product or component subjected to abnormal stresses and operating conditions.

This limited warranty flows only to the original purchaser or first end-user purchaser. If the Product fails to conform to this warranty and is returned by purchaser in accordance with AGLW published Warranty Service Program during the warranty period, AGLW will, at its option, either repair or replace the Product or the non-conforming part thereof, or reimburse the purchaser for the purchase price of the specific Product. For purposes of clarity, "repair or replace the Product or the non-conforming part thereof" does not include any removal or reinstallation costs or expenses, including without limitation labor costs or expenses. If AGLW chooses to replace the Product and is not able to do so because it has been discontinued or is not available, AGLW may replace it with a comparable product.

THE WARRANTIES AND REMEDIES SET FORTH HEREIN ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES WHETHER, EXPRESS OR IMPLIED, INCLUDING ALL WARRANTIES OR MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND ALL WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE OR TRADE. Purchaser's exclusive remedy, and AGLW's sole liability, for any nonconformity or defect in any Product shall be only those explicitly set forth herein.

LIMITATION OF LIABILITY: AGLW will not under any circumstances whether as a result of breach of contract, breach of warranty, tort, strict liability or otherwise be liable for consequential, incidental, special or exemplary damages, including but not limited to, loss of profits or revenues, loss of use of the Product or any other goods or associated equipment or damage to any associated equipment, cost of capital, cost of substitute products, facility of services, down time cost, or claims of claimant's customers. AGLW's liability on any claim of any kind for any loss or damage arising out of, resulting from or concerning any aspect of this warranty or from the product or services furnished hereunder shall not exceed the price of the specific Product which gives rise to the claim.
